

The following is a Grand Canyon Lottery Primer for do-it-yourself river runners seeking a permit to float the Colorado river in Grand Canyon during the 2014 rafting season. This Primer covers all the pages you will encounter to sign up for the Lottery.

Follow along as we go through the twenty or so different steps to apply. This includes info on how to set up a User Profile (That part is free). This primer provides a demo from an actual lottery application for a 2014 permit, including how to use the calendar. We also review the Profile section and the \$25 payment process. You can print this Primer out to use as you go online and step through the NPS process.

Good luck...remember, in a waiting list, at least you were assured a date unless you died waiting...and now, you pay and may never win before you die.

WELCOME TO THE WEIGHTED LOTTERY!

Use this website to submit lottery applications for noncommercial Colorado River rafting permits:

1. Create and manage your user profile, which contains your contact information, points, river trip history, and all lottery applications you've submitted or are listed on.
2. Create and submit a lottery application for a noncommercial (private) river trip when a lottery is open.
3. Pay lottery application fees.

In addition, you may also use this website to:

- Add your email address and opt-in to receive notifications of upcoming lotteries.
- Make changes to your pending lottery application at any time before the lottery closes.
- Monitor the status of your pending lottery application, i.e., make sure payment for applicable fees was successfully processed, verify participants you listed as Potential Alternate Trip Leaders (PATLs) have confirmed their PATL status on your application, and double-check there are no disqualifying problems with your lottery application.
- Find out whether or not your application was successful in a lottery.
- Fill out and submit your noncommercial river permit application, print a trip participant list, and pay permit fees (if you won a launch date in a lottery).

FAQs

PERMITTING PROCESS OVERVIEW

The following is a quick overview of the permitting process. [A more detailed description of each step in the application and permitting process is given here.](#)

- Step 1: Create a profile.** All persons listed as either a trip leader or a Potential Alternate Trip Leader (PATL) on a river lottery application must have a user account (profile) in this system.
- Step 2: Login and create your application.** Once you have a profile (and a lottery is open), you can login at any time before the lottery is run to create and submit a lottery application.
- Step 3: Submit your completed application.** All PATLs listed on your application must login to this system and accept their PATL status before the lottery drawing date; PATLs failing to do so will not be included in your lottery application.
- Step 4: Pay lottery application fee.** A completed application is not active until fees are paid. Lottery applicants are required to pay a \$25 application fee only once per launch year. Once an application fee has been paid for a launch year, you can apply in all lotteries for that launch year for no additional fee. Pay the \$25 lottery application fee through this website.
- Step 5: Lottery occurs on designated date.** After the lottery, you will be notified of the success/failure of your lottery application by email. You can login at any time to view the status of your lottery application. If you win a launch date, you will pay a trip deposit fee (\$400 for standard size trips, \$200 for small size trips).
- Step 6: Complete a river permit application, draft trip participant list, and pay permit fees.** If successful in the lottery, you will complete a noncommercial river permit application and pay your river permit fees. You will also submit a draft trip participant list. All of these are done online through this website.
- Step 7: River permit is issued.** When the above steps are complete, the Grand Canyon River Permit Office will issue your river permit.

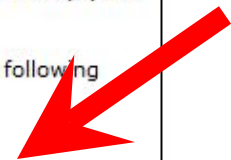

Congrats! You have been Profiled! Now you can log in to the Lottery...

The fine print... there is no such requirement if you go through Grand Canyon using the NPS river concessionaires. This means while do-it-yourself folks are checked multiple times and by Federal Law Enforcement Rangers at the Lee's Ferry boat ramp, commercial passengers do not have to go through such scrutiny. Limiting do-it-yourself access to the river was first established in the 1950's to protect the commercial interests leading guided river trips in Grand Canyon. Just so you know...

This “make sure” you accurately list your last river trip” screen pops up. Your photo ID will be checked at the put-in. Commercial passengers do not have to do this...just sayin... and remember, preference points are given to those who stay away

Before you apply in a noncommercial river lottery, make sure your profile accurately lists your last recreational river trip (noncommercial or commercial) through any portion of the Lees Ferry to Diamond Creek section of the Colorado River. Failing to accurately list the launch year for your last trip will result in the cancellation of any trip you might win through the lottery.

In your profile you currently list your last Grand Canyon recreational river trip launch date as February 2011. You can list a more recent trip launch date on your Profile page (the page you just came from). To change your launch date to a more recent one, look in the "Most Recent Grand Canyon River Trip" section and click on "update".

You must be at least 18 years old on a chosen launch date, or the creation of the lottery application will fail.

Q: What if I fail to enter my date of birth correctly?

A: Your entry must match the date of birth you created with your profile. Three consecutive failed attempts will result in your account being locked. Once your account is locked only the Grand Canyon River Permits Office can unlock it.

Q: Why is this step necessary?

A: This section provides an additional level of protection for your account.

Q: My date of birth is listed incorrectly in my profile, I need it changed and my account unlocked. How do I do this?

A: Please fax the River Permit Office (928-638-7844) a request to have your date of birth changed and include all of the following: your legal name, date of birth, mailing address, email, and phone number(s). Your request will be responded to during normal business hours. **DO NOT SEND US AN EMAIL WITH YOUR DATE OF BIRTH.**

Q: Why is date of birth even required on this site?

A: Grand Canyon National Park's river permit system includes three important rules to ensure fairness: 1) an individual can have only one profile in the lottery system, 2) an individual can go on a maximum of one recreational river trip per calendar year, and 3) an individual will get less than five chances in the lottery if they have been on the river within the last four years. Date of birth information is key in helping us identify and distinguish individuals while ensuring the above two rules are met.



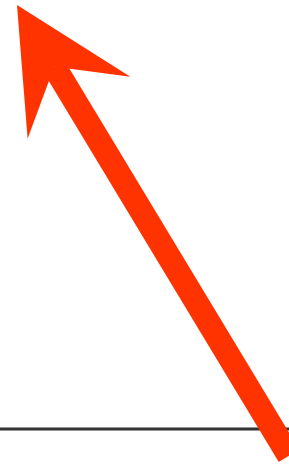

It's a "wait"ed lottery favoring permit holders who have not been in the last 5 years or more.

Q:

Why do you need to know the date of my last year commercial or private trip down the Colorado in order to create my profile?

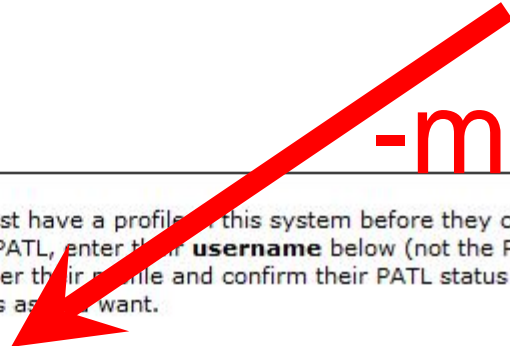
A:

In order to give everyone a fair chance to experience a raft trip down the Colorado, individuals are limited to one trip (commercial or private) down the Colorado per year. Moreover, we weight the odds of winning the lottery, giving more chances to those who have not been down the river recently. Note that we do check the accuracy of "last date down the Colorado" for all applicants listed on a permit application against our historical commercial and private records before issuing each permit; false statements of "last trip" date will result in cancellation of the permit.

This prevents the permit holder from having up to date river experience. This does not apply to concessions river passengers. Don't ask us why, ask the NPS!

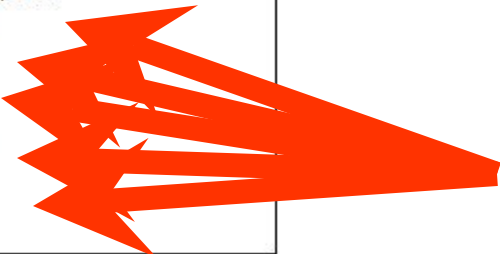

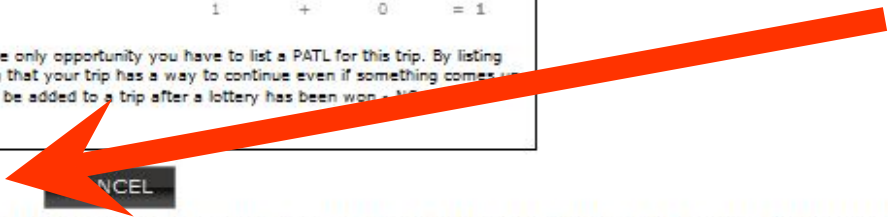

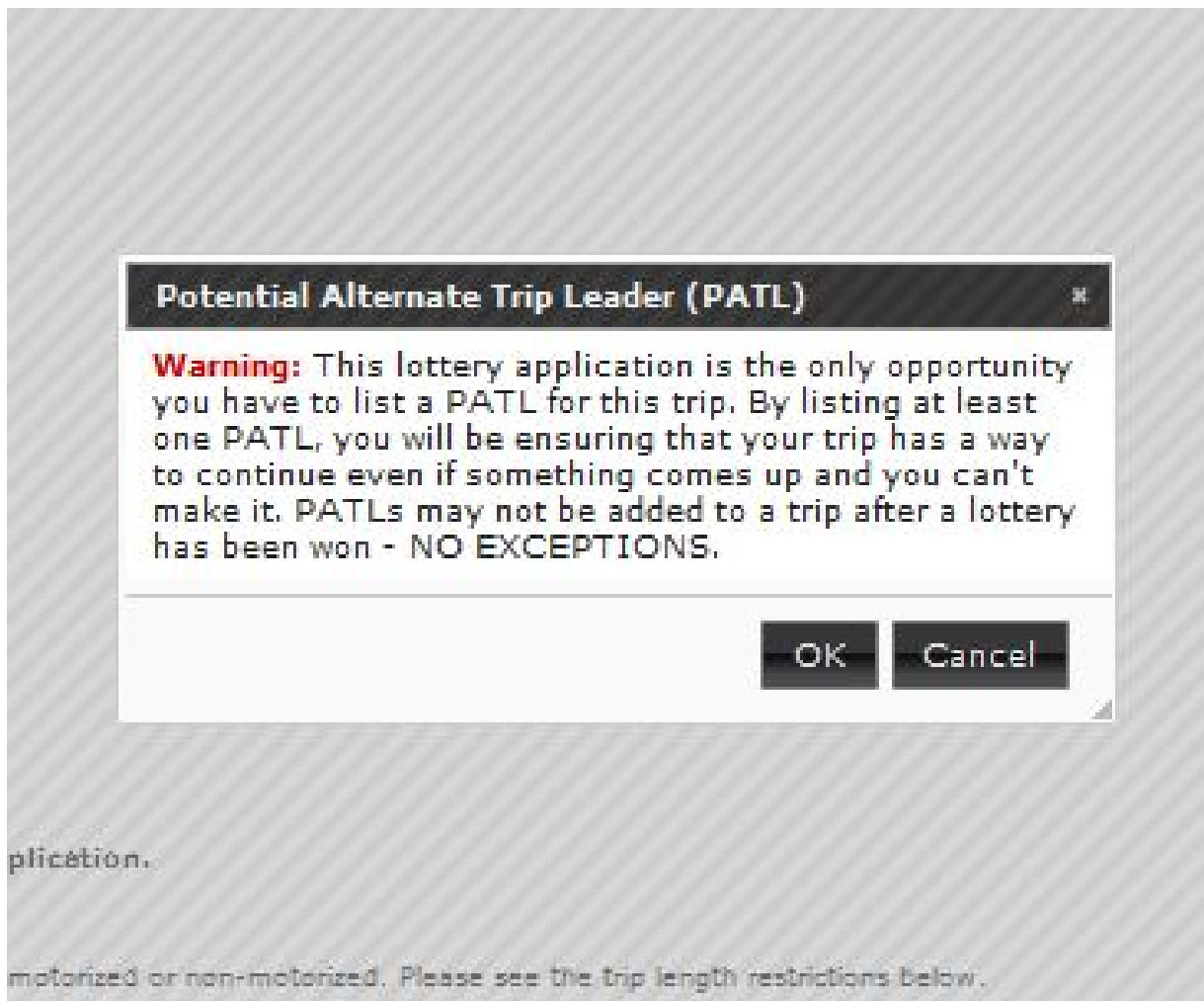
Trip Length Restrictions: Non-motorized, noncommercial trips launching within the following time periods are allowed the following number of days between Lees Ferry and Diamond Creek:

- 16 days (15 nights) May through Aug
- 18 days (17 nights) Sep 1-15
- 21 days (20 nights) Sep 16 - Oct 31
- 25 days (24 nights) Nov 1 - Feb 29
- 21 days (20 nights) Mar 1 - Apr 30

Motorized, noncommercial trips launching in the motorized season (April 1 through September 15th) are allowed a maximum of 12 days (11 nights) between Lees Ferry and Diamond Creek.

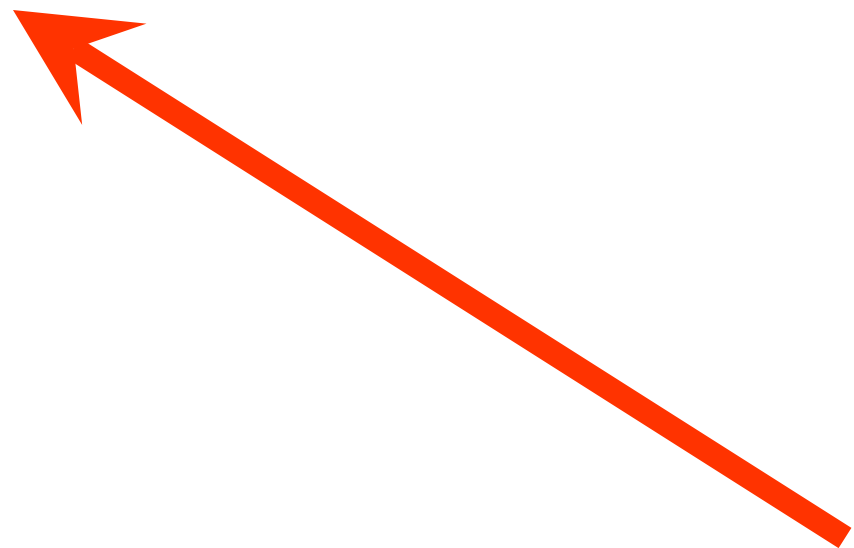
