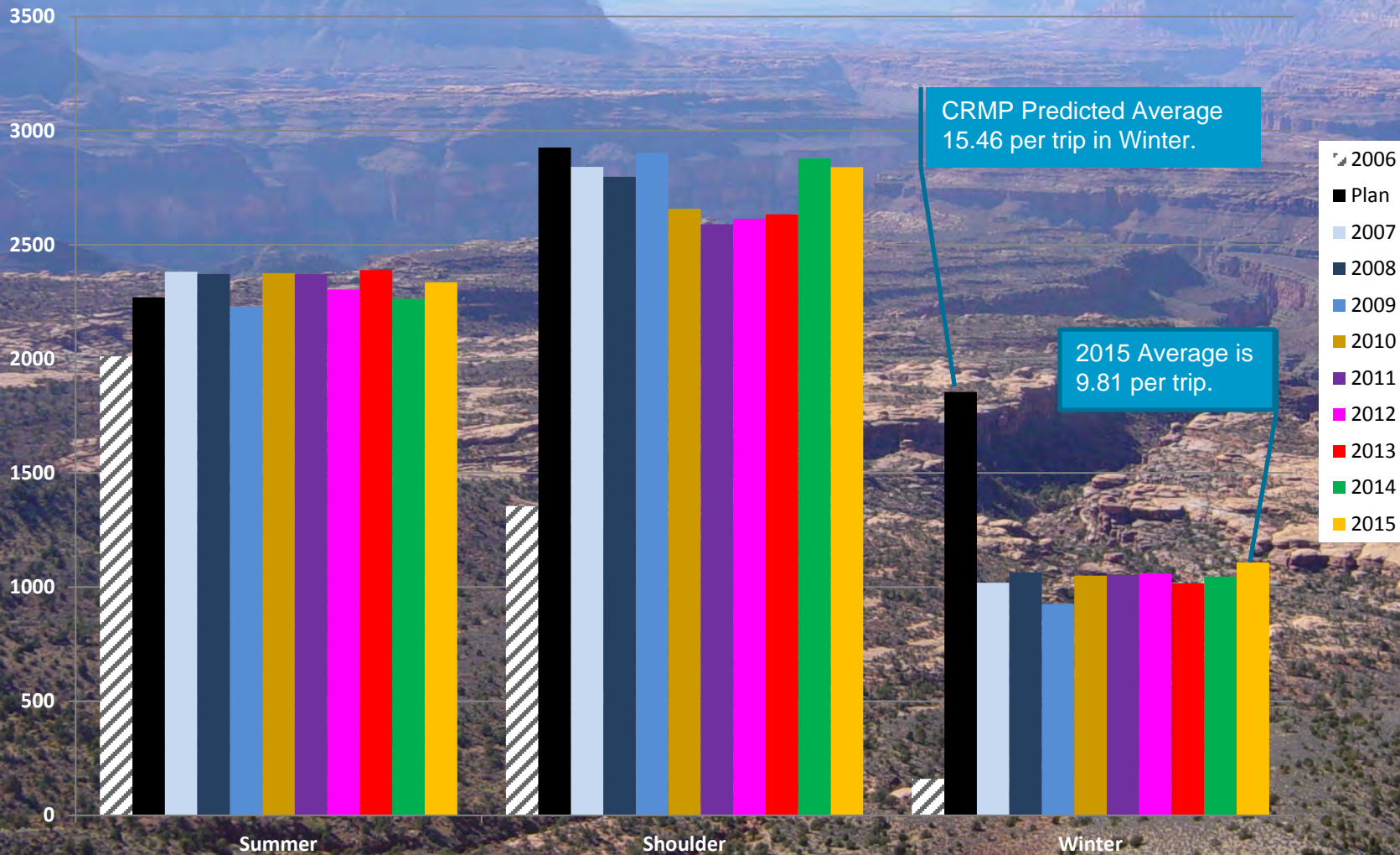

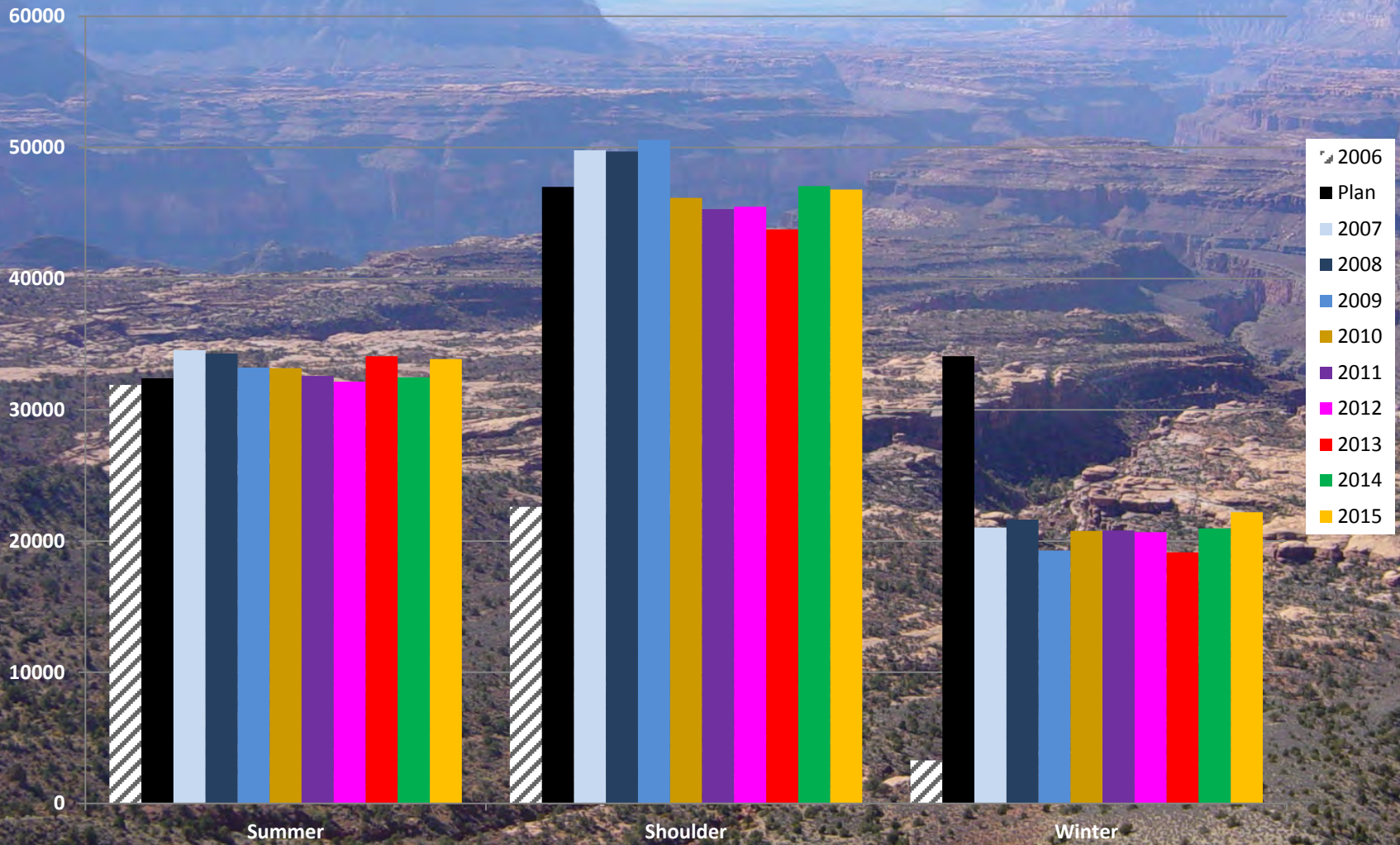
Noncommercial Trips by Season



Noncommercial Participants by Season

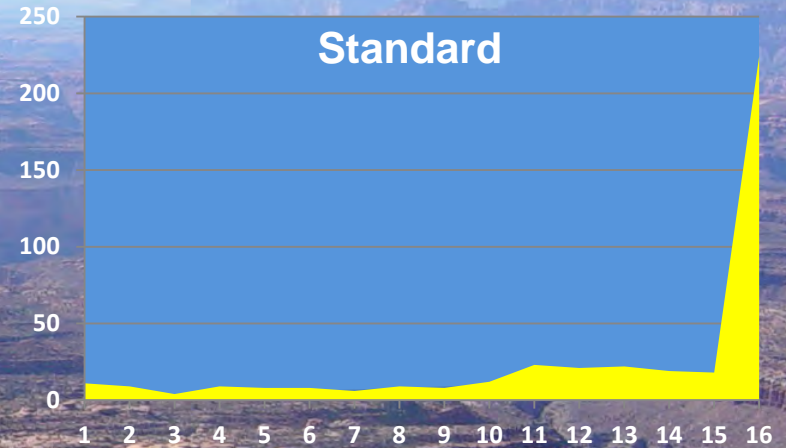


Noncommercial User-Days by Season

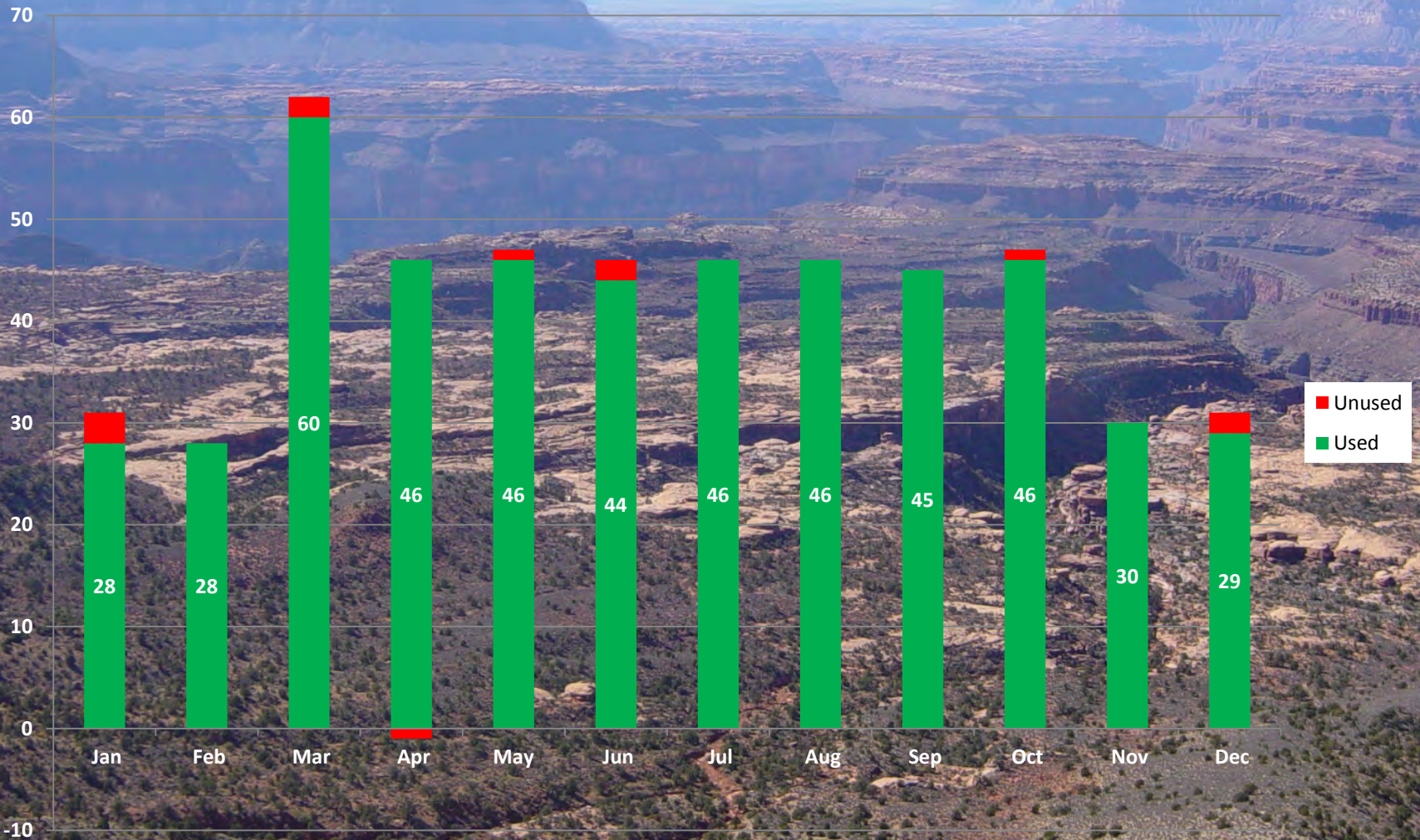

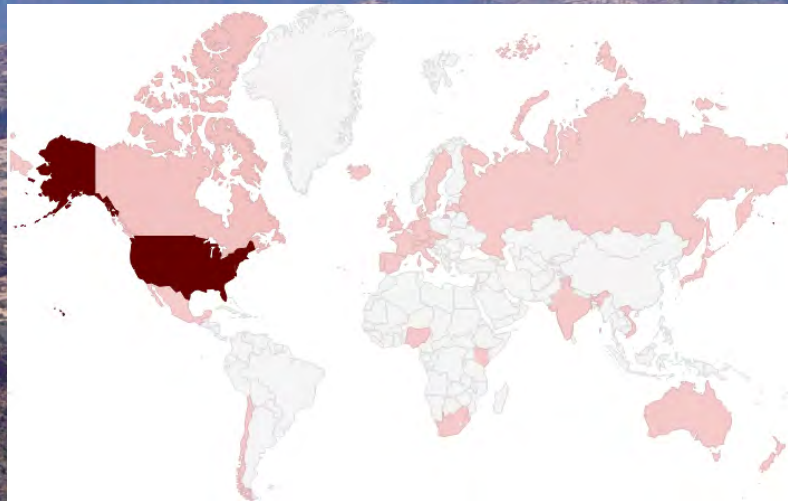

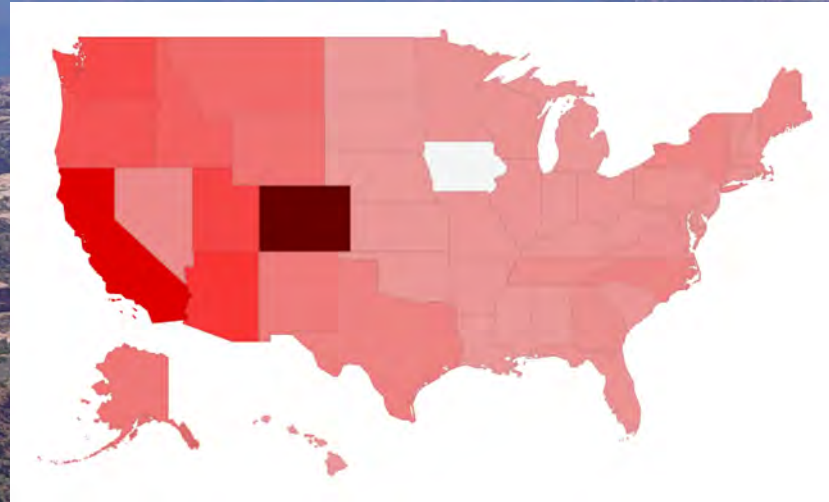

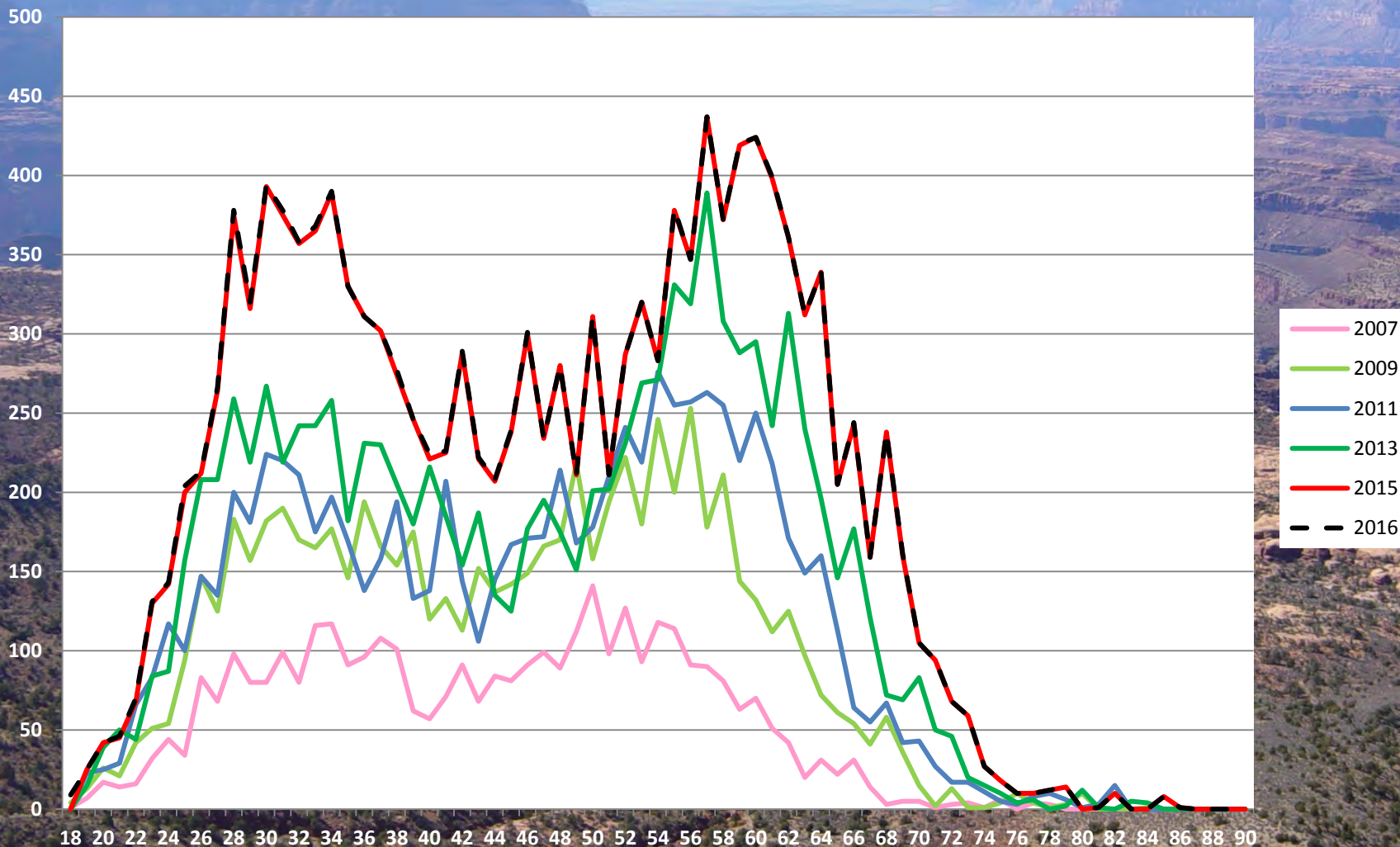

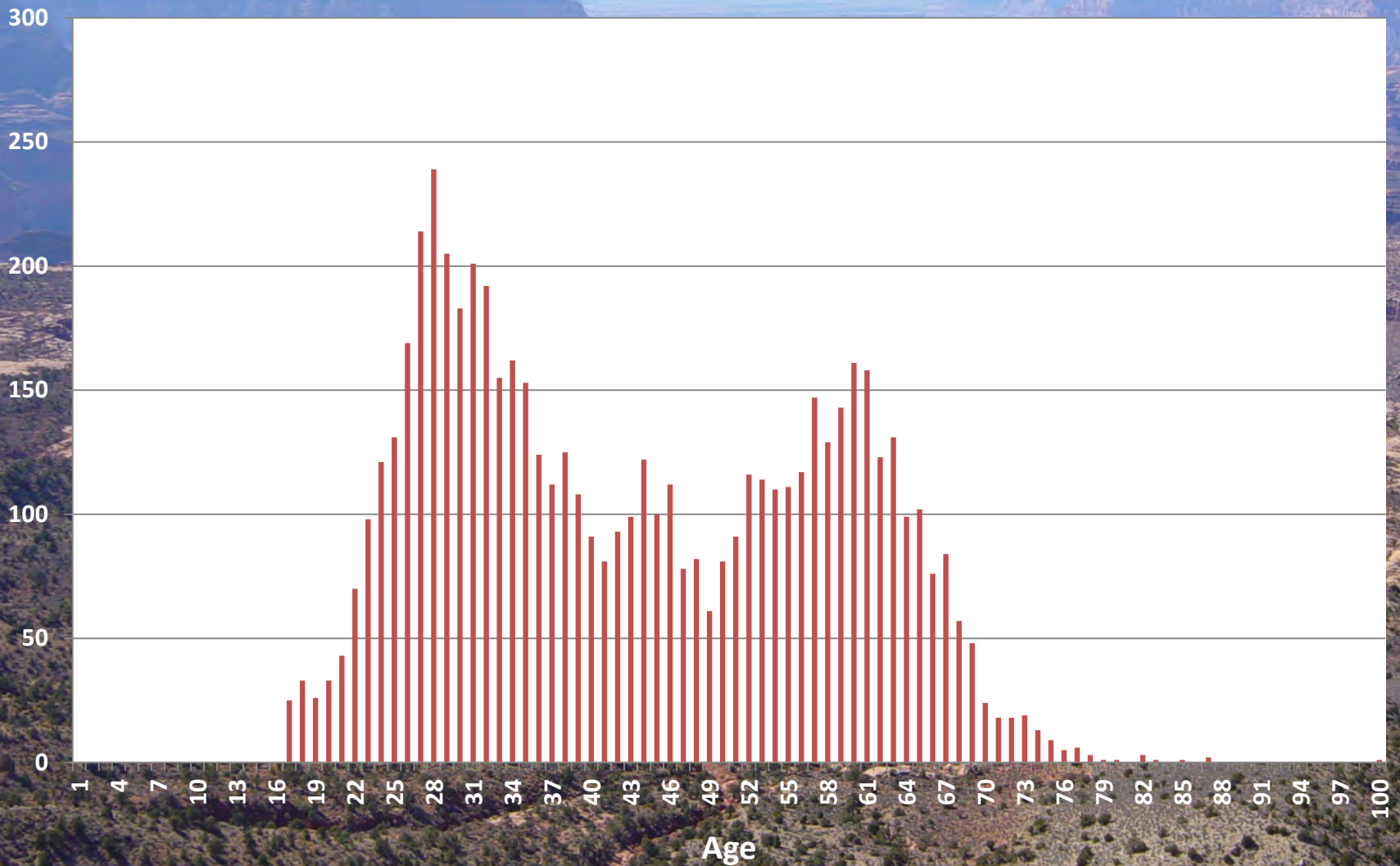

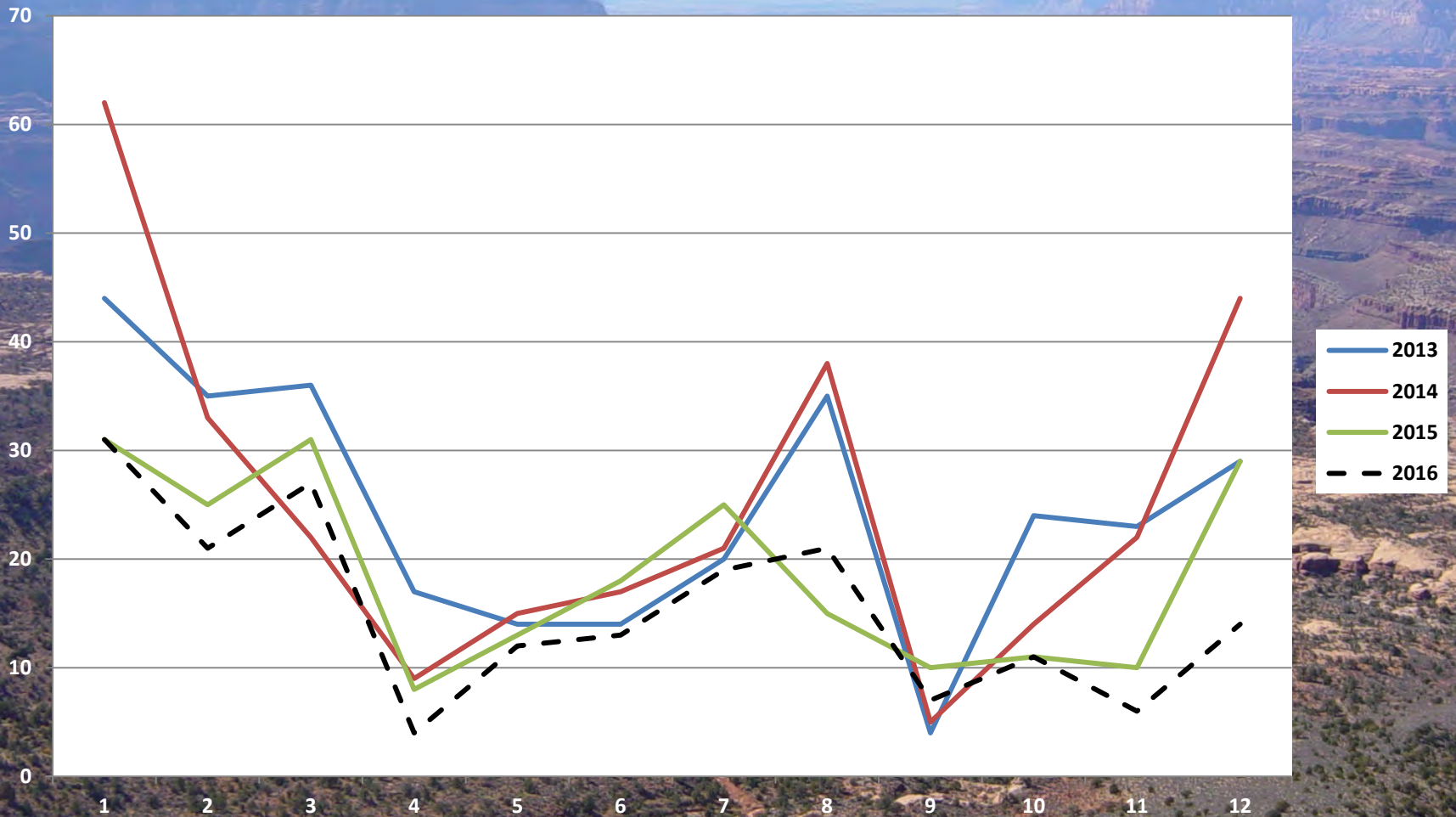

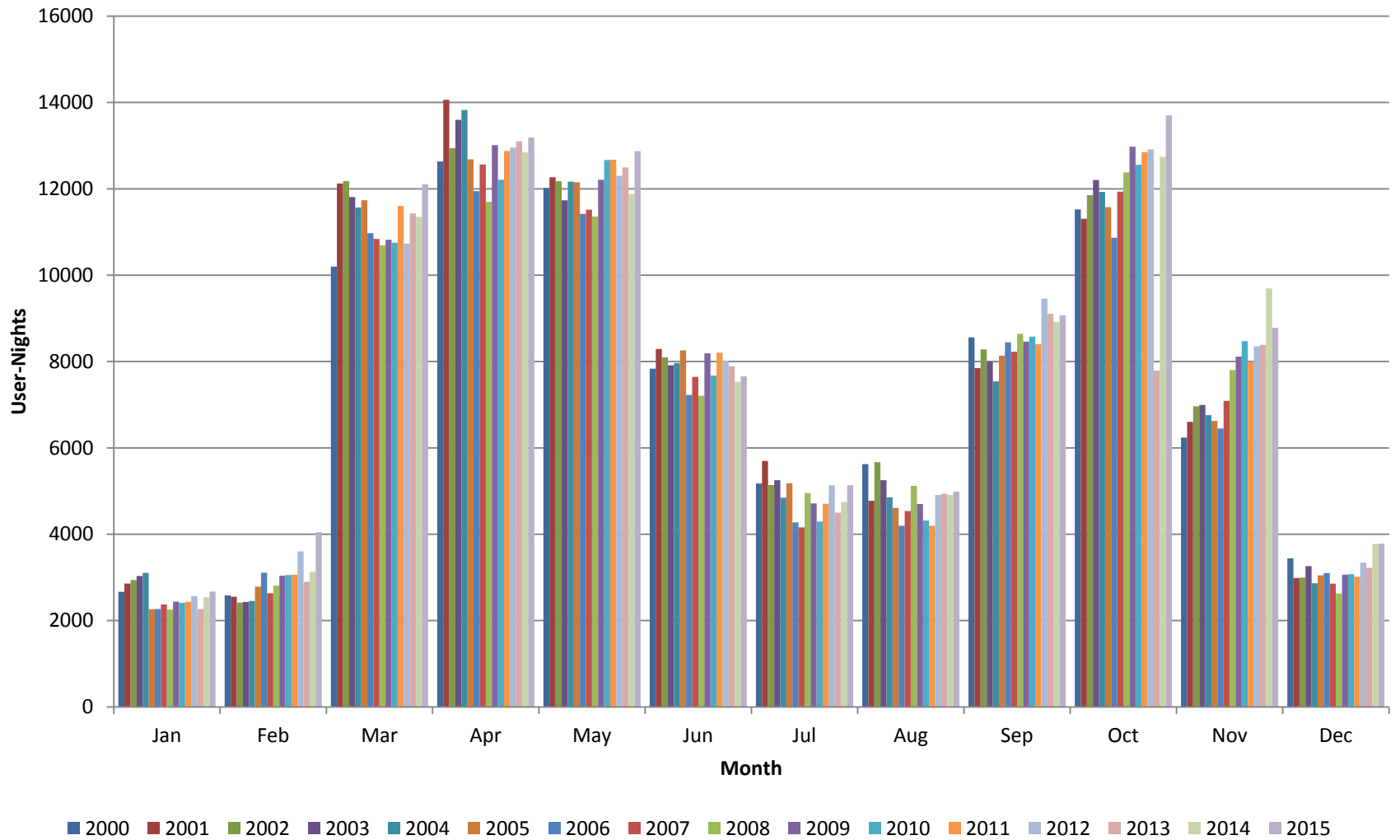

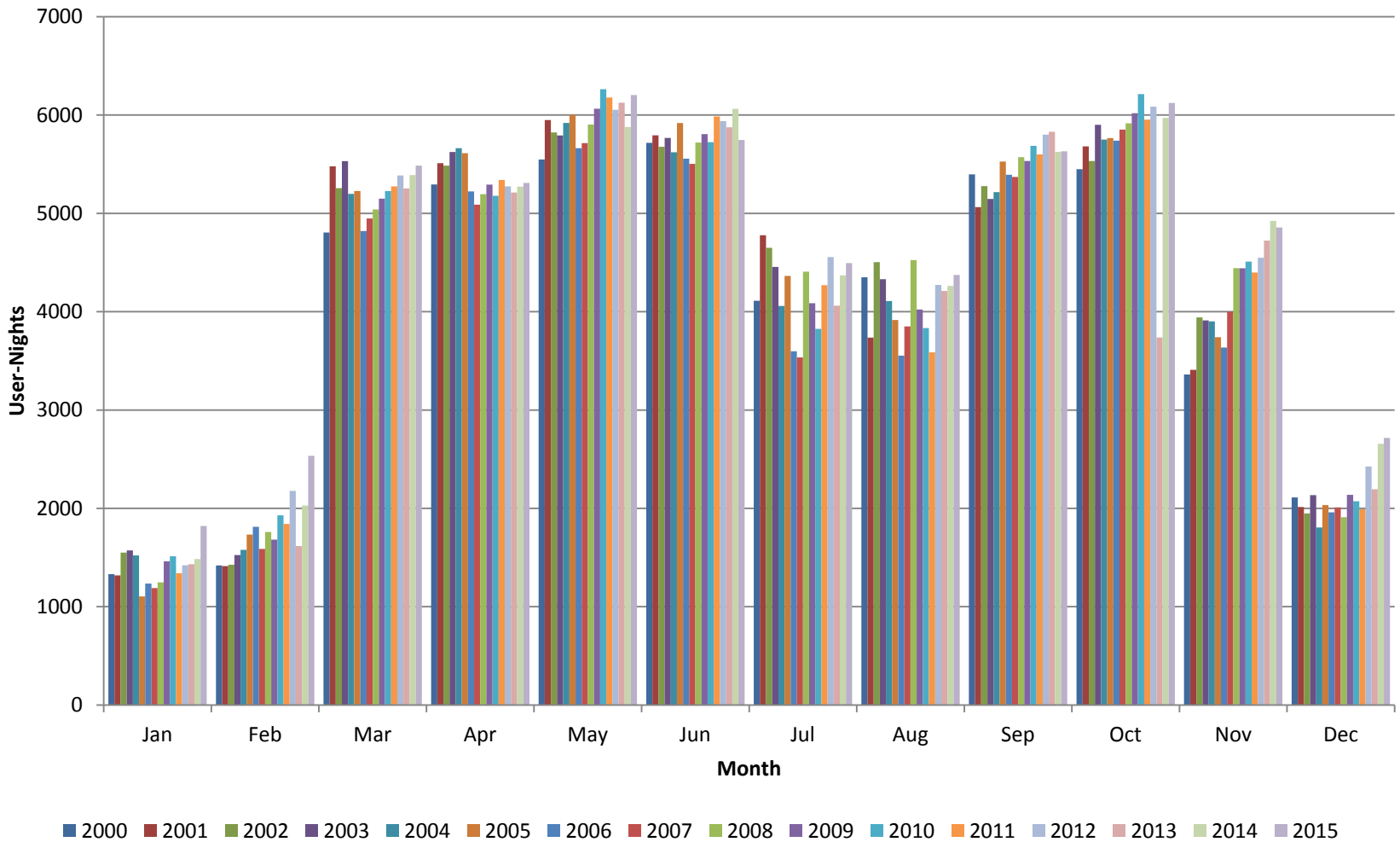
Backcountry Use Trends, 2000-2015

Corridor + Non-Corridor

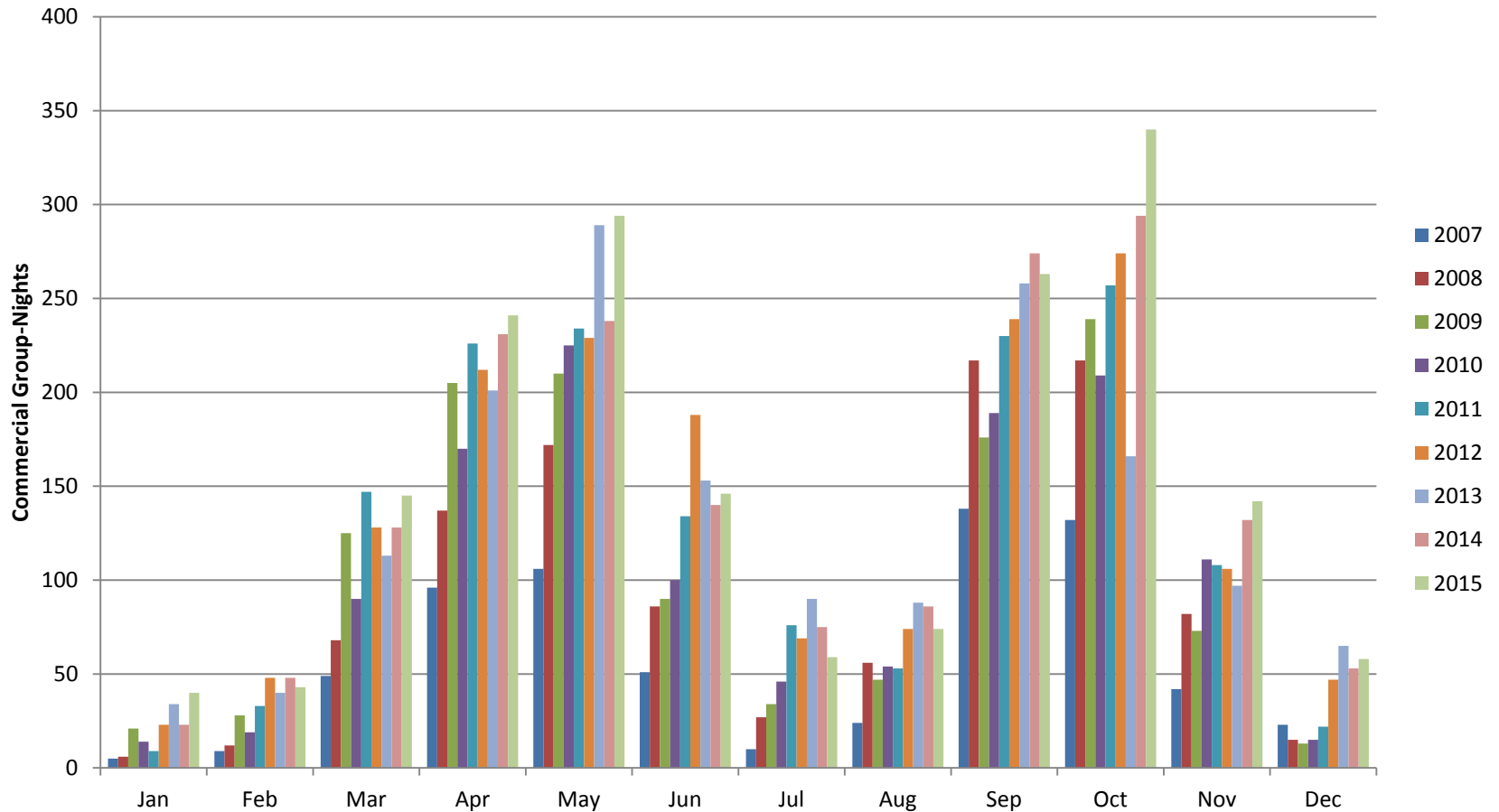

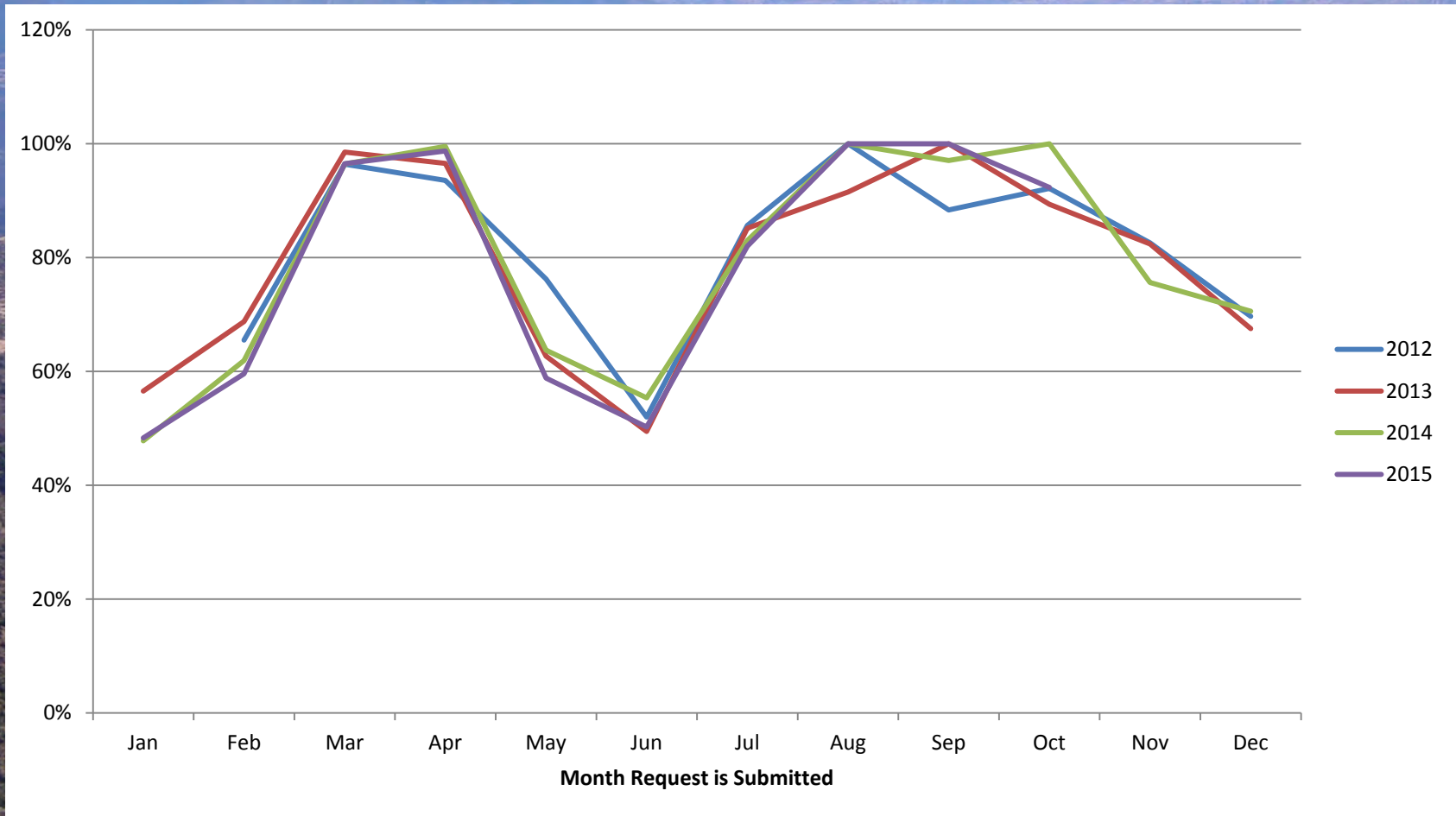
